- * Participants are requested to submit correct information in Visa Request Form.
- * Participants are advised that they will only receive 14 DAYS TRANSIT VISAS. These visas will await them at the airport (Dubai and Sharjah ONLY) on arrival, hence it is essential to give Flight No., date, airport and the time of arrival.
- * Immigration and sponsorship laws demand that Participants handover their visas & passport to us and it will be returned to Exhibitors when they leave U.A.E.
- * Participants must confirm their departure flight from UAE and arrange to leave within the 30 days allotted.
- * Overstaying the allotted 30 days incurs an immigration penalty of Dh. 100 (US\$ 30) per day for each person, to be paid by the Exhibitor at the immigration on departure
- * Official Fee for each normal visa: US\$ 50/= per head and urgent visa: US\$75/= per head
- * No other airport should be used for arrival than the airport ticked above.
